The University of California (UC) and American Cargoservice (ACS) have entered into a logistics agreement for ACS to provide transportation and related services for the University.

Individual UC campuses may have different shipping procedures that will require flexibility on our part. We are prepared to accommodate the specific requirements of each campus.

ACS has successful business relationships with some UC campuses, but others do not know our capabilities. During the next few weeks we hope to get acquainted with you to learn more of your transportation requirements and how they match up with our services.

Related Services:

The physical movement of freight is part of the supply chain process, but government and industry regulations also determine shipment documentation and procedures. We stay current on these regulations and can provide assistance to the University for regulatory compliance.

ATA Carnets may be a significant issue for some campuses. ACS has extensive experience with Carnets and while we can secure Carnets for UC, we can also advise when to use, or not use a Carnet. Alternative import procedures may be more appropriate in some situations.

We encourage UC people to discuss these issues with us early in the shipping process.

Some facts about ACS...

Global Coverage: ACS has over 2600 agency locations in the U.S. and worldwide.

Services: “Full Service” means we provide “door to door” service including shipment documentation and related services.

Transport Modes: ACS is licensed to perform air freight, ocean freight and domestic truck services. We are bonded and insured.

Cargo Insurance: ACS can provide high value cargo insurance for shipments that UC does not wish to place under its own insurance policy.

Dangerous Goods Shipments: ACS people are trained in DG shipments and we are registered with DOT as required by 49 U.S.C 5108.

Customs Clearance: ACS is not a Customs House Broker, but has a 16 year relationship with Western Overseas Corp., a nationwide Customs Broker. UC imports will be Customs cleared in a seamless, efficient manner.

INCOTERMS 2010: While UC does not normally “sell” products in the usual sense, INCOTERMS do apply to UC shipments. ACS can help determine the proper INCOTERM for specific situations.

Training: ACS offers training sessions in various logistics subjects, tailored to the specific interests of the individual UC campuses.

Safety: ACS takes every precaution to ensure that we operate in a safe manner for people and cargo.
